## BY-LAWS

### SECTION-I

#### ADMINISTRATION

1. The President, Management Committee of P.P.N. College, Kanpur, U.P., India, shall be the Patron of the Association.
2. The Principal, P. P. N. College, Kanpur U.P., India, shall be the Chairman of the Association.
3. The Executive Committee shall consist of six members. Two members shall be elected by the Founder Members from among themselves. Three members shall be elected

from the life members of the Association. One member shall be the representative of P.P.N. Memorial Society, the parent body of the College.

4. The Executive Committee shall suggest a panel of six candidates for the posts of Convener and Co-Convener (three names for each post) and submit it before the Chairman. The honorable Patron of the Association will be pleased to appoint the Convener and Co-Convener of the association from the list provided by the Chairman. The Chairman, the Representative of the Society and Treasurer shall not be liable for election to the aforementioned posts.
5. The term of Executive Committee will be of five years.
6. The Chairman shall preside at all meetings of the Association and the Executive Committee of the Association. She/he shall have general and active management of the business of the Association and shall see that all orders and resolutions Executive Committee are put into effect.
7. In the absence of Chairman the Convener shall perform the duties and exercise the powers of the Chairman.
8. The Convener shall also be the custodian of all the secretarial record of the Association including managing the website. He/she shall receive requests for membership, circulate agenda of the meetings (on the advice of the Chairman) ensure that all general members are notified of all meetings of the Association. She/he shall record, publish, and distribute minutes of all meetings of Executive Committee as directed the Chairman by from time to time.
9. The Co-Convener shall, in the absence the Convener, perform the duties and exercise the powers of the Convener.
10. All the contributions in favor of Alumni Association will be received and spent by the Treasurer as decided by the Executive Committee. The Treasurer will maintain all records of money received and disbursed. All expenditures shall be made by cheque

drawn on a bank selected by the Executive Committee and signed by the Patron and the Convener.

11. In the event of death/resignation/removal of any of the members of the Executive Committee, the remaining elected members shall have the right to co-opt by simple majority any Life member of the Association as member of the Executive Committee. Such a co-opted member shall be for the remaining period and shall have all rights and responsibilities as a member of executive committee. The process of co-option shall be completed within a period of two months after the death/resignation/removal.
12. In the event of equal number of votes cast on any issue, the Patron shall have a deciding vote.

## SECTION II

### MEMBERSHIP

1. An individual is eligible to become Life Member of Alumni Association of P.P.N. College, Kanpur by depositing a sum of Rupees 1000/ only as membership fees if he/she has been a student at the college.
2. Former faculty in the P.P.N. College is also eligible to become Life Member by depositing a sum of Rupees 1000/ only as membership fees.
3. An individual is eligible to become General Member (for two years duration) of Alumni Association of P.P.N. College, Kanpur by depositing a sum of Rupees 200/ only as membership fees if he/she has been a student at the college.

**NOTE:** The Executive Committee shall reserve the right of admitting a person as a member. The Committee reserves the right to refuse membership without assigning any reason.

### MODE/PROCESS OF MEMBERSHIP

1. The eligible individuals desirous of membership of Alumni Association will deposit with the convener the membership form completely filled.

2. The convener, Alumni Association will recommend the membership after verifying the eligibility of the individual seeking membership executive committee whose decision shall be final and binding.
3. The fee for membership will then be deposited through draft/ cash/ cheque/ e-transfer only with the Convener.

**SECTION-III**

**FINANCES**

1. The fiscal year of the Association shall begin on November 1 of every calendar year.
2. The financial policies of the Association shall be governed by a budget adopted by a simple majority of the members present at the annual meeting of the Executive Committee.
3. All funds received in payment of membership fees or by any other means shall be used as the operating funds of the Association, unless otherwise specified.
4. A financial report of the Association shall be prepared by the Treasurer at the end of each fiscal year, and shall be made available to the members present at annual meetings of the Executive Committee and shall be displayed on the notice board outside the Convener's office.
5. Funds of the Association will be operated jointly by the Patron and the Convener.

**SECTION-IV**

**LOCAL ALUMNI ASSOCIATIONS**

1. Any group of ten or more alumni may, upon petition and at the discretion of the Alumni Association of P.P.N. College, Kanpur be granted permission to organize a Local Association. A Local Association may be established based upon country, metropolitan area and geographic region. However, no such Local Association shall be formed in Kanpur, U.P.

2. The Constitution of the Association shall supersede the constitutions of Local Associations. The Constitution of the Local Associations shall be based on the constitution of the Alumni Association and the same shall be approved by the Alumni Association of P.P.N. College, Kanpur.
3. All Local Association members must be the life / general members of the Association.
4. Local Associations shall elect their own officers and function as independent organizations with respect to local social or service matters.
5. Each Local Association may assess local dues. Each Local Association shall pay an annual Association fee as determined by the Executive Committee.
6. The Executive Committee has the authority to dissolve any Local Association that fails to comply with purposes, policies and the rules set forth by the Association.
7. Local groups, which do not meet the requirements of the Association, are expressly prohibited from using the name of Alumni Association of P.P.N. College, Kanpur (PPNCAA) or any local chapter designation.

SECTION-V

**MEETINGS OF THE ASSOCIATION**

1. The Patron in consultation with Executive Committee shall hold annual meetings of the Association at a time and place (if applicable), prior to the end of October every year, The members must be notified of the date of meeting with the agenda no less than 21 days prior to the date of meeting.
2. Special meetings of the Association may be called at any time by the Convener, upon the written request of at least three members of Executive Committee. The general members must be notified of special meetings 21 days prior to the meeting.
3. The Chairman shall govern the deliberations of all component parts of the Association assembled in meeting.

4. The agenda for Annual Meeting shall include annual report, budget, amendments in the constitution, if any, and any other item which the Executive Committee believes relevant.
  5. If the meeting is adjourned the adjourned meeting shall be held on a date (venue if applicable) within 14 days and no quorum is required for an adjourned meeting. The business transacted in such a meeting shall be valid and considered legal.

**SECTION-VI**

**MEETINGS OF THE EXECUTIVE COMMITTEE**

1. The annual meeting of the Executive Committee shall be held by the end of the first week of October to finalize the Annual Report and Statement of Accounts or any other issues initiated or completed during the year for presentation at the Annual Meeting of the Association. The notification and agenda of such a meeting shall be given to all current members no less than twenty one days prior to the meeting.
2. Special meetings of the Executive Committee shall be held after every four months. However such meetings may be called at any time by the Convener or Co- Convener as the case may be, or upon written request from one third members of the Executive Committee, with notification and agenda given to all members no less than twenty one days prior to the meeting.

**SECTION-VII**

**NOMINATIONS AND ELECTIONS**

1. The Executive Committee in the month of August/September (of the election year), shall invite nominations from life members of the Association for the specific positions as specified in the constitution. At least 14 days notice to this effect shall be emailed by the committee to the life members and/or put on the website of the Association.
2. Only the life members of the Association shall be eligible to be nominated and elected.
3. If a candidate wishes to withdraw his/her nomination, she/he can do so before the expiry date of notice. The Executive Committee after consultation among its members shall

select a panel of five nominees within one week's time after the expiry date of the notice.

The committee shall circulate to members through e-mail/and website a panel of five nominations for voting. The Founding Members of the Association shall have the right to nominate the entire panel or any of its members, as the case may be, by their simple majority vote. The privacy of approval / disapproval by individual members of the Association must be maintained by the Executive Committee. The process should be completed by the end of the month of September.

4. The process of nomination/election, because of the spread of membership, may be organized through cyber / web site.
5. The elected members of the Executive Committee shall assume office at the close of the annual meeting of the Association and shall serve a five-year term without any remuneration.

## SECTION- VIII

### **REMOVAL OF AN EXECUTIVE COMMITTEE MEMBER**

A three-fourth favorable votes of the members of the Association may remove an Executive member who is no longer available to serve actively or has acted against the interests of the Association. However, a 14 day's written notice and an opportunity to respond to the charges shall be given to him/her before removal.

## SECTION- IX

### **DUTIES AND POWERS OF THE EXECUTIVE COMMITTEE**

1. The Executive Committee shall have jurisdiction over all component parts, affairs and assets of the Association.
2. The overall control and administration of the Association shall be vested with the Executive Committee. The Executive Committee shall be the final administrative authority to take decisions on behalf of the Association as provided in this constitution. The Executive Committee shall also have the authority to take decisions on any extraordinary matter or situation, not mentioned in the constitution.

3. The Executive Committee shall give direction to the members of the Association to achieve its purposes and implementation its policies.
4. The Executive Committee shall serve as a liaison between P.P.N. College, Kanpur, U.P., India, and the Association.
5. The Executive Committee on behalf of the Association shall enter into agreements and sign Memorandum of Understanding with P.P.N. College, Kanpur, U.P., India and cooperate other organizations with similar purposes.
6. The Executive Committee shall admit new members, organize meetings, prepare budget, initiate and / or undertake new academic, informational, cultural and other activities as deem appropriate; and distribution and transmission of communication.
7. The Executive Committee may appoint, employ, dismiss, or remove employees for the Association, when appropriate.
8. The Executive Committee shall discharge to the best of its ability all other responsibilities as laid out in this constitution. To do so it may, from time to time, as it deems necessary, create/abolish additional positions specified/unspecified in the constitution, and appoint any life member of the Association to such positions to discharge its responsibilities.

## DEFINITIONS

**D. 1 Executive Committee:** Chairman, Convener, Co- Convener, Treasurer and six Executive members shall constitute the executive committee of the Alumni Association.

**D. 2 Founder Member:** The life members enrolled during the year 2011, starting from Jan. 01, 2011 till Dec. 31, 2011, shall be termed as Founder Members.

**D. 3 Life Member:** Former student of the college who has deposited a sum of Rupees 1000/ only as membership fees and approved by the Convener after verification of eligibility.

## Rules & Regulations

of

ALUMINI ASSOCIATION P.P.N. COLLEGE, KANPUR.

### Membership

#### 1. Life Members

- (a) Members who have already contributed Rs. 1,000/- in 2011 & afterwards shall continue to the Life Members in present Society.
- (b) A former student of PPN College, Kanpur, by depositing a sum of Rs. 3,000/- lumpsum to the funds of this Society.
- (c) A former faculty of PPN College, Kanpur, by depositing a sum of Rs. 3,000/- lumpsum to the funds of this Society.

#### 2. Ordinary (General) Members

Any person if he/she has been a student or faculty of PPN College, Kanpur is eligible to become Ordinary (General) Member of the Society for a period of one year by depositing Rs. 1,000/- to the funds of the Society.

3. The Governing Body shall be responsible for vetting the Membership application and shall submit the approved application to the Patron for final approval.
4. The Patron shall have the sole decision in admitting or rejecting the candidates for membership of the Society and shall reserve the right regarding the same without specifying the reason.
5. A person shall cease to be a member of the society in case of death, resignation, insanity, non payment of subscription for more than two years, conviction and if in the opinion of the Governing Body the person is incapable of being a member of the Society.
6. A member of the Society or Governing Body or Sub-Committee shall not take part in any discussion or vote on any matter in which he/she may be personally interested or which may concern him personally and or financially.

7. No member of the Society shall be entitled to Vote at any meeting of the Society or Governing Body unless he has paid his subscription & arrears, if any, of the previous year or years and unless his/her name is shown in the register of members of the Society.
  8. The following shall not eligible for membership of the Society.
    - (a) Any person who is not a former student or former faculty of the P.P.N. College, Kanpur.
    - (b) Any person who is in current employment of P.P.N. College, Kanpur.
    - (c) Any person who is a current student of the P.P.N. College, Kanpur.
  9. Any person may be admitted as member by the Governing Body by reason of his reputation in any profession or art or academic life and for such period as the Governing Body may decide, subject to the final approval of the Patron.

## MEETINGS

- (1) The Society shall meet atleast once a year (GENERAL MEETING) at PPN College, Kanpur. The ordinary business to be transacted at the Annual General Meeting of the Society shall be all or any one of the following :-
  - (a) To elect the committee called the Governing Body.
  - (b) To elect the office bearers of the Governing Body who shall hold office for three years.
  - (c) To pass the Annual Budget and Report on Accounts.
  - (d) To Consider & Pass the Balance Sheet and Income & Expenditure Account of the Society.
- (2) A General Meeting of the Members of the Society shall have power to add, alter, amend or delete any of these regulations by 3/5 Majority provided the due notice of such proposed alterations etc. is given to all the members of the Society atleast 7 days before date of the meeting. A copy of such additions, alterations, deletions or amendment to the regulations shall be filed with the Registrar within one month after they are made. However, Rule (1) of Administration cannot be altered, amended or deleted.

- (3) An extra ordinary meeting of the society may at any time be called at the instance of the Governing Body to consider any business of importance and shall be so called at the requisition in writing of 1/3rd of the members for time being, setting forth the matter of business to be transacted thereat.
  - (4) The quorum at all the General Meetings of the Society shall be a simple majority of the members on Roll. If the meeting is adjourned for want of quorum, it shall be held within a month thereof at such time and place and at such notice as the Chairman may fix.
  - (5) An annual meeting of the Society shall be held in the month of October except when the Society or the Chairman decides otherwise.

## ADMINISTRATION

- (1) The General Body of the Society shall consist of all the members of the Society. The affairs of the Society shall be managed by Governing Body which shall consist of the following :-
  - (a) The President of Committee of Management of PPN College, Kanpur shall be the Ex-Officio Patron of the Society.
  - (b) The Principal of PPN College, Kanpur shall be Ex-Officio Chairman of the Society.
  - (c) Apart from this the Convener, Co-convener, Treasurer & Six additional Members shall be elected by the Society at its Annual General Meeting and shall hold office for a term of three years. The sitting members will be eligible for re-election at the Annual General Meeting of the Society.
- (2) If during the year any member/members of the Governing Body should become incapable of discharging his/her duties or should resign, then the remaining members of the Governing Body shall elect another member in his/her or their place for the residue of the term.
- (3) The Governing Body shall ordinarily meet once in six months for discharge of business but in case of urgency, the Patron or the Chairman may call a meeting at any time.
- (4) At a meeting of Governing Body the quorum shall consist of simple majority of which the presence of the Chairman and Convener/Co-Convener is mandatory. Meeting

adjourned for want of quorum shall be held at time and place within a month and at such notice as the Chairman may decide. No quorum is necessary for an adjourned meeting.

- (5) The Governing Body shall have full control over the funds of the Society.
- (6) In the event of equal number of votes being cast on any issue in a meeting the Patron shall have the deciding vote.
- (7) The Governing Body may, time to time, sanction such clerical or other establishment as it deems necessary for assisting the office bearers in carrying out their functions & duties.
- (8) The Governing Body shall have power to constitute Sub-Committee for any purpose and shall frame rules of their Constitution and working.
- (9) The Governing Body shall prepare an Yearly Budget which shall be submitted for approval at the Annual General Meeting of the Society.
- (10) The Governing Body shall appoint, suspend or dismiss any or all employees of the Society.
- (11) The Governing Body shall be entitled to frame Rules & Regulations for giving effect to any of the objects of the Society.

**FUNCTIONS & DUTIES OF THE CHAIRMAN**

- (1) The Chairman shall preside over all meetings and conduct the proceedings thereat.
- (2) Sanction expenditure by the Society or by any of its Sub-Committees of a sum not exceeding Rupees Fifteen Thousand at any one time.
- (3) The Chairman after approval by the Governing Body shall appoint, suspend and punish the staff of the Society and appoint ministerial and menial staff of the Society.
- (4) The Chairman shall supervise & control all Sub-Committees belonging to the Society in the manner he/she deems proper & expedient.

- (5) The Chairman shall allot special duty to the office bearers or make alternative arrangements of the duties in case of their absence from station. The said rule shall not apply to the Patron.
- (6) The Chairman shall perform such functions & duties as may be entrusted to him/her from time to time.

**FUNCTIONS & DUTIES OF THE CONVENOR/CO-CONVENOR**

- (1) The Convenor shall call ordinary & special meetings of the Society or the Governing Body and its Sub-Committees, under instructions of the Chairman in conformity with the Rules & Bye-laws of the Society.
- (2) The Convenor shall record the proceedings of the Meeting of the Society and the Governing Body and to propose, in consultation with the Chairman, items of business for all meetings.
- (3) The Convenor shall maintain and keep all registers, books, papers and records of the Society and the Governing Body and to issue receipts.
- (4) The Convenor shall correspond with parties, establishments, associations, firms or individuals and to enter into agreement with them on behalf of the Society after getting approval from the Governing Body.
- (5) Perform such duties as may be, from time to time, be entrusted to him by the Chairman of the Society or the Governing Body.
- (6) The Co-Convenor shall exercise such powers, duties and functions as may be delegated to him/her by the Chairman of the Society or the Governing Body or act as Convenor in his/her absence.


