Terms & Conditions

Agreement of allotment to the vendor for running a canteen for 11 months (April 2026 to February 2027) in the campus from the date of agreement. Further period extendable with the permission by the management committee.

1. The vendor shall deposit the full allotment/ annual charge at the time of allotment.
2. Reserve Price Rs. 45,000.00
3. The Annual Charges shall be renewable every session with 20% increase.
4. The canteen is allotted for the period of 11 months only, subject to renewal on mutual consent in writing.
5. The vendor shall obtain the License form Nagar Nigam, Kanpur/Competent Authority and display the same at door or front outside wall of the canteen containing the name of owner and License Number.
6. The vendor shall put up mask on the face.
7. The vendor shall compensate losses and damages if any suffered on account of any act or omission or bad quality of food, cleanliness, violation of direction of Health Department of Nagar Nigam, Kanpur Nagar/Competent Authority etc.
8. The losses & damages will be recovered from the canteen owner/vender.
9. There should be a sub meter for electricity for the canteen, whose bills, would be borne by the vendor.
10. The canteen vender would not make any fire cooking except tea and coffee.
11. The canteen vender will sell ready to eat/drink items and its price should not exceed the printed rate.
12. The canteen vender should maintain a waste bin and no waste should be littered around.
13. Alcohol / tobacco and other toxic items are strictly prohibited in the campus.
14. The college reserves rights to cancel the contract and close the canteen, on the directives of the management committee at any point of time.
